If we do not receive photographs, your application will be returned whether you are a past vendor or not. All food must be approved regardless of whether you have participated previously in any Clearfield City festival. Approval is based on a series of criteria: appearance and quality of food, consumer demand for food, past working relationship with Community Services staff, reputation of vendor and/or references, customer service, and locality (live, work or attend school in Clearfield). Upon approval, applications will be assigned in accordance with the registration policy. In order to insure a standard of quality and balance for our fair, a limited amount of commercial vendors will be allowed. Vendors must have food to sell the day of the fair.
